CURRENT UPDATES 5.1.21

While we continue to navigate the COVID-19 pandemic and our re-opening, the Weber Center is committed to and will be following the science based recommendations from the CDC, State of Wisconsin and the La Crosse County Coulee Collaborative.

To ensure the safety of our patrons, employees, volunteers, and visiting artists, the Weber Center has made significant improvements to our HVAC system, with the addition of a state of the art ionization air purification system manufactured by AtmosAir. We have also reduced seating capacities to aid in physical distancing. Our seating capacities will either increase or decrease depending on local, state, and CDC recommendations. Patrons over the age of 2 are required to wear face masks that properly cover both their mouth and nose, and physically distance between groups and parties as much as possible while on the premises. The mask requirement applies to those who may be fully vaccinated or unable to wear a mask. While we want to remain accessible to all, those who are unable to wear a face mask are not recommended to attend in person performances at this time.

As we continue to progress through the COVID-19 pandemic, we will continue to assess our policies and procedures and our ability to ensure the safety of our patrons, employees, volunteers, and visiting artists.

QUICK FAQ's for patrons who plan on attending a performance

- *Patrons over the age of 2 are required to wear face masks that properly cover both their mouth and nose, and physically distance between groups and parties as much as possible while on the premises. The mask requirement applies to those who may be fully vaccinated or unable to wear a mask. While we want to remain accessible to all, those who are unable to wear a face mask are not recommended to attend in person performances at this time*
- *We have reduced our seating capacities to allow for more physical distancing while inside our venues. These capacities could fluctuate up or down depending on local, state, and CDC recommendations.*
- *Guests should self-screen for COVID-19 symptoms before arriving at the Weber Center. Please do not attend if you have been exposed to COVID-19 or are exhibiting any symptoms. In this case, please contact boxoffice@webercenterarts.org to speak with a box office associate.*
- *Our new box office hours are Monday through Friday, 3 pm – 5 pm for phone sales only. We encourage you to try our online ticketing anytime outside these hours. Walk up box office sales will only be open one hour prior to show time.*
- *Hand sanitizing stations are located at every entrance and are also widely available throughout our entire facility.*
- *We are deploying enhanced cleaning and disinfecting practices facility wide. All high contact surfaces are disinfected regularly and all seating areas are disinfected before and after each performance.*
- *Concessions sales are temporarily suspended.*
- *Guests are encouraged to keep a minimum of 6 feet of space between themselves and others while moving around our facility*
- *All Weber Center employees and volunteers are screened for COVID-19 upon arriving, and are instructed to stay home if they show any symptoms. All Weber Center employees and volunteers are required to properly wear a face mask at all times.*
